Tournament General Bowling Rules

Payout:

First place prize is guaranteed. Additional payouts based on number of entries

-The tournament is a 3 game series plus handicap to determine standings.

Handicap is established as follows:

- Handicap score is based off of 200. Participants will receive 80% of the difference between their average and 200.

(Ex.: $200 - 155$ [avg] = $45 \times .80 = 36$ pins handicap per game)

- Participants that currently hold a USBC sanction card must provide the number at registration. Those not registered may do so onsite.

- All USBC rules will apply.

1. - Format: Singles - Bowl 3 games on one pair of lanes
2. -Bowlers Must present a **current 2013-2014 league standing sheet along with registration.**
3. -Bowlers who re-enter can only win one prize.

Eligibility to bowl:

- Each squad entry requires registration either in advance or onsite.

- Tournament Director reserves the right to rerate or refuse any tournament participant.

- Score Corrections:

All score corrections must be done by a Tournament Official to be accepted. Score corrections by other than a tournament official will be scored a Zero.

- To **pre-register** for the tournament you may do the following:
